## 2023 IN REVIEW

Yield results reported to The Roland L. Geyer Agency so far tell the story of variability this season. Crop insurance claims have been filed, of course, and we are working through 150 of them presently. Adjusters are working and coordinating schedules is a primary task for them to achieve next steps. Whether few or many, it is our priority to process every claim quickly and accurately. We work to see claims settled as soon as possible.

Eyes have been on the Farm Bill process in Congress with extensions being approved without new legislation being written yet. Thankfully, crop insurance is regulated by separate legislation, the Federal Crop Insurance Act of 1938, so the lack of a new Farm Bill does not impact current or 2024 coverage.
