New for 2010 Options for insuring food grade soybeans

If you raise food grade soybeans, The Roland L. Geyer Agency has information on a new option for insuring these crops differently. Varieties included in the program include:

- Large Seeded Food Grade
- Low Saturated Fat
- Small Seeded Food Grade
- High Protein

• Low Linolenic Acid

Farmers raising any of these products under contract will have the option to have their price election determined by the price of that contract. This will give you the most precise and effective coverage possible for these specialty crops.

Biotechnology Endorsement Available for 2010

The Biotechnology Endorsement program allows producers to receive a premium rate reduction if at least 75 percent of the corn acreage within the insured unit is non-irrigated corn for grain planted to a hybrid or hybrids containing specific biotech traits. Last year, the program was expanded to cover biotech traits from the Monsanto Company, Syngenta, and Pioneer/DuPont. This includes YieldGard® Corn Borer, YieldGuard® Rootworm, Roundup Ready® corn, Herculex®, Genuity®, Smart Stax®, Herculex XTRA® and AgriSure® traits. Check with your seed supplier to determine if your hybrids qualify for this program.

This endorsement does not waive or otherwise affect the EPA's existing refuge requirements. There will be random reviews requiring collection of plant tissue samples from units the grower reports as qualifying for the BE premium rate reduction.

If you are not in compliance with the rules for the BE program, your corn policy for 2010 is voided, you may owe the company up to 20 percent of your premium, and, criminal charges could possibly be filed.

The BE applies to both Actual Production History and revenue policies. *The Roland L. Geyer Agency* has information on the program and we will discuss the requirements and potential discounts with you.

Report Changes for 2010

For your policy to have its maximum effectiveness and validity, please report any changes for the 2010 growing season to *The Geyer Agency*. Changes we need to record include:

Additional or reduced acreage
 Change in marital status
