Acreage and Planting Date Reporting Deadline Is June 30

It's time to report your acreage and planting dates for your crop insurance coverage. **The deadline is June 30.**

To help you through the reporting process, we recommend the following:

- **1.** Certify your acres at the county FSA office.
- **2.** Request copies of your certification.
- **3.** Bring those copies to The Roland L. Geyer Agency.
- 4. Rest assured you receive the best possible coverage from the crop insurance agency you know and trust!

In addition to the reporting deadline, the potential for storms also places some urgency on the process. If a damaging storm would occur, having your information submitted as soon after you finish planting as possible will improve the claims process.

We will work with you to be sure all the required reporting and documentation is completed on

Replanting Reporting Requirements Changed

Unusual weather this spring means replanting is a possibility for many area farmers. If you need to replant due to weather consequences, contact **The Roland L. Geyer Agency** immediately! Federal regulations regarding replanting have changed and will impact you due to a new sequence of events required for coverage.

The Roland L. Geyer Agency is here to help you receive the maximum benefit of your crop insurance coverage. And that begins by reporting the need to replant before you take action.

When you replant, it is important to leave a few strips in the affected field so an adjuster can evaluate them. This will all add up to achieving the best results on your claim.

Remember, contact us immediately if you need to replant any portion of your total acres.

If Weather Damage Occurs - Call Us First

When a field receives hail or other weather damage during the growing season, make **The Roland L. Geyer Agency** your first call. We will set the claims process in motion for you leading to a settlement if possible.

It's hard to monitor each field in its entirety during the growing season. That's why re-inspection is always available to you. If you see suspected damage while harvesting, you have the opportunity to have adjusters come out and inspect your crop.

Leave sample strips for re-inspection standing in the field where you see the damage.

Our experience has been that company representatives are extremely willing to conduct re-inspections. In larger fields, sample strips need to be left in several locations.

Whether in season or during harvest, call us if you suspect hail damage. We will go to work for you to attain the best possible settlement. And don't forget to leave sample strips in the fall.

office be identical to what you give us for your crop insurance coverage. In the event of a claim, having the same information in both cases will speed processing and ease any concerns that arise.

You can help expedite the process by requesting copies of your documents from the FSA office. These original copies of your documents, particularly maps, are very helpful and more readable.

If you have any changes in your farming enterprise, please notify us of those as soon as possible.

If it's inconvenient for you to come by our office, just give us a call and we'll be happy to come to you to take care of this process. Remember, this is also your deadline for certification to the Farm Service Agency (FSA) as well and stopping there first will make our process smoother.
