PLANTED ACRES REPORTING DEADLINE IS JULY 17

The deadline for reporting planted acres - July 17 - will be here before you know it! The Geyer Agency makes sharing this essential information easy. Before July 17, drop off your reports at the office in person, fax to 712-662-3247, email to tgeyer412@outlook.com, or mail to PO Box 129, Sac City, Iowa 50583, **ahead** of the deadline. We are happy to pick up the FSA documents at your farm after they have been certified. Just notify us by phone. Remember, the reports you submit to FSA and to The Geyer Agency must match for your crop insurance coverage to be in full effect.

The Geyer Agency recommends:

1. Certify your acres with the county FSA office.
2. Supply copies of your certification paperwork to The Roland L. Geyer Agency.
3. Rest assured you receive the best possible coverage from the crop insurance agency you know and trust!

The acreage and planting dates you report to the FSA office must be identical to what you give The Geyer Agency for your crop insurance coverage. In the event of a claim, having the same information in both cases will facilitate the best outcome.

We strongly recommend you get us your planted acres before July 17, 2023. Sharing your information as soon as you complete planting will relieve concern over missing the deadline. We never know if a damaging storm will occur so having your information submitted right after you finish planting will improve the claims process. The Geyer Agency will work with you to be sure all the required reporting and documentation is completed on time, to be sure your coverage is fully in effect as expected.

If you have any changes in your farming enterprise, please notify us of those as soon as possible.

Remember, your deadline for certification with FSA is the same as for crop insurance: Monday, July 17, 2023. We appreciate your business and will always do our best to serve your crop insurance needs well!

Did you know Iowa had more disaster declarations due to flooding than any other state in the nation from 1953 to 2018? PROTECT YOUR LIVELIHOOD WITH CROP INSURANCE COVERAGE

We cannot control the weather so ensuring your livelihood with crop insurance provides peace of mind. If a severe weather event impacts your crop, make The Roland L. Geyer Agency your first call. We will work on your behalf for you to receive a settlement should damage exceed your policy's established threshold.

For the best results with your weather claim, leave sample strips for re-inspection standing in the field where you see the damage. In larger fields, sample strips need to be left in several locations. Re-inspection is always available later in the season as well.

Even if you see suspected damage during harvest through the combine window, you have the opportunity to have adjusters come out and inspect your crop.

Whether in season or during harvest, call us if you suspect hail damage. We will go to work for you to attain the best possible settlement.
